RIGHT OF ENTRY LICENSE APPLICATION Non-Environmental

Return the completed application along with a non-refundable fee in the amount of **\$3,150 USD (\$4,196 CAD)** and a print or sketch of the proposed premises with dimensions, coordinates and directions. This Right of Entry Request is limited to a 30 day period. The exact date ranges will be required as will the use of flagmen when near an active rail line. Flagmen will be at the sole expense of the applicant. If the applicant needs to use the premises beyond the 30 day period, a new application and fee will be required. Non-environmental Right of Entry applicants have the option of acquiring a 6 month license for an \$18,000 USD (\$23,686 CAD) one-time fee. The rush fee and flagmen, if required, are not included in this cost.
